- Contractors must be newly enrolled or reactivated in the Samsung HVAC Preferred Dealer Program during the promotional period to participate.
- Grandfathered contractors during the promotional period are eligible for standard Samsung HVAC Preferred Dealer Program benefits, but not eligible for benefits offered through this conversion program.

- Samsung HVAC will evaluate system registrations on the third Monday of every month. The \$1,000 USD cash bonus will be paid out once per month. If the minimum system registration requirement is met before the evaluation period, the Contractor will receive the \$1,000 USD cash bonus in the next pay cycle. All earnings will be paid out by January 31, 2025.
- A promotional code for the \$500 USD branding points will be issued via email by January 31, 2025. Branding points are redeemable for items on the Samsung HVAC Promo Shop (samsunghvac.com/promo).
